Terms & Conditions of Engagement under sponsored projects

1. It is not an offer of appointment in CCMB / CSIR, temporary or otherwise. It is a placement in a Project. It would, therefore, not confer any right implicit or explicit for your consideration for regularization / absorption in any of the Labs. / Institutes of CSIR or under any other scheme as applicable to identified casual workers against any of CSIR posts, even if engagement or deployment / placement is for more than 240 / 206 days in a year.
2. Your engagement is co-terminus with the project or till such time the job performed by you in the existing Project and the date of your tenure as extended by Director, CSIR-CCMB Hyderabad, whichever is earlier.
3. HRA is not admissible in case CCMB hostel/quarter accommodation is availed and necessary deductions like Licence fee, Water, Electricity charges etc., will be made from your stipend. For this purpose, an undertaking in the prescribed proforma is to be submitted.
4. No travelling allowance will be admissible to you for reporting to duty.
5. You will not be allowed to discontinue your engagement without seeking prior approval of the Director, CCMB. In case you wish to discontinue the engagement prior to completion of your tenure, you must submit one month's prior notice indicating specific reasons for not continuing or deposit one month's stipend in lieu of the notice period. The engagement shall cease from the date stipulated by the Director while accepting the resignation. Further, Director, CCMB may terminate your engagement in the project by giving one month's notice or one month's consolidated stipend in lieu thereof without assigning any reason and you will have no right against CSIR in any circumstances.
6. You will not divulge any information relating to the work of CCMB, which you may come to know during your engagement with CCMB to any party.

7. Your engagement will be subject to submission of the following documents at your own expense at the time of your reporting for duty.
- (i) Medical Certificate of health and physical fitness issued by the Medical Officer of CCMB Dispensary situated at CRF building, CCMB Annex-2, CCMB, Hyderabad **OR** any Medical Officer of Govt. Dispensary / Hospital in your city / town.

    - (b) Self attested copies of certificates/marks/transcript of educational/ technical qualifications/Community certificate;
    - (c) Experience/Relieving certificate from the present employer, if any;

    - (f) All the above **original documents** - for verification.
  - (iii) Attestation forms (duly completed)/ Character Certificate in the enclosed form.
8. The Director, CCMB, Hyderabad whose decision shall be final and binding on both the parties to the contract, shall determine any matter not specifically stated therein.
9. You are entitled for one day leave for each completed month's service.
10. You will not be entitled for any medical facility either at CCMB Dispensary or under CS (MA) Rules. However, under emergent circumstances treatment/ consultation is allowed at CCMB Dispensary. You are not entitled to reimbursement of medical expenses, if any.
