Screening criteria adopted by the duly constituted Screening Committee for the above mentioned post is as follows:

Essential qualification(s) and MD/DNB/MS in any discipline
(OR)

Essential qualification(s) with Minimum 3 years of experience in a reputed hospital of bed strength 300 or more

Further, incomplete applications like without receipt of application fee, relevant category certificate for age relaxation wherever applicable, applications not received through proper channel from regular employees working in CSIR laboratories/Institutes, Government Departments, Autonomous bodies, Public Sector Undertakings, Government Funded Research Agencies etc. have not been considered.

Based on the above mentioned screening criteria adopted by the duly constituted Screening Committee, the list of provisionally **Shortlisted candidates** to be called for Interview for the Post of Senior Technical Officer (1)/Medical Officer is attached as **Annexure-I**.

The candidates listed in **Annexure-II** are **not shortlisted** and the reason for rejection is indicated against each candidate's name.
